## **Pouchoscopy Prep**

We have scheduled you for a Pouchoscopy on \_\_\_\_\_ at \_\_\_\_\_ am/pm.

- ( ) Mid-America Surgery Institute, 5525 W. 119<sup>th</sup> St, Overland Park, KS, 66209, Suite 100.

Please register by \_\_\_\_\_ am/pm in order for us to provide our services in an efficient manner.

You will need to purchase the following: all are available over the counter at any pharmacy:

- 1 Small bottle of Miralax powder (4.1 oz or 116 grams)
- 1 32 oz. bottle of Gatorade (**not red or purple**)
- 1- Fleets enema

### **YOUR PREP INSTRUCTIONS ARE AS FOLLOWS:**

1. The **DAY BEFORE** the procedure you will be on **CLEAR LIQUIDS ONLY** all day. This includes black coffee, tea, soda – such as Coke/ Pepsi, (Diet is ok), 7-Up/Sprite, Apple juice, Gatorade, Popsicles, Jell-O, broth, and bouillon. **NOTHING** red or purple.
2. At **5:00pm** Mix the entire bottle of Miralax with the Gatorade and drink within 2 hours.
3. You may have all the clear liquids you would like until midnight. **DO NOT EAT OR DRINK ANYTHING AFTER MIDNIGHT.** If your procedure is 1pm or later, you may have 6oz of water only up to 4 hours prior to the procedure.
4. You will need to purchase 1 Fleets Enema over the counter. Follow instructions on the box. We suggest that you start the enema 1½ to 2 hours before leaving to come to your appointment.
5. **PLEASE DO NOT USE ANY LOTIONS, BABY OIL, VASELINE, BODY SPRAY OR MASCARA THE MORNING OF THE PROCEDURE.**
6. Do not take any medications the morning of the procedure unless directed to do so.
7. Please note that like surgery, procedures take varying amounts of time depending on their complexity. While we try to remain on schedule, occasional prolonged procedures may delay subsequent ones. We will try to keep you advised of any delays.
8. **YOU MAY BE SEDATED FOR THIS PROCEDURE. PLEASE MAKE SURE YOU HAVE A DRIVER; SOMEONE YOU KNOW THAT CAN TAKE YOU BACK HOME.**
